Dear Governor Cuomo,

We are seeking your support on a local control issue that will promote economic development and reduce preventable injuries and deaths on our roads. We ask that you support legislation that would give localities the power to set their own speed limit.

Existing state law prevents municipalities from adopting an area speed limit lower than 30 miles per hour. Some jurisdictions are able to lower that speed limit to 25 miles per hour on a street-by-street basis, while others must petition the New York State Department of Transportation, both of which are expensive and time-consuming propositions. In order to have a consistent, community-wide speed limit below 30 miles per hour, municipalities must petition the State Senate and Assembly to pass a bill—also a time-consuming proposition, that is rarely successful.

There are several benefits to giving localities the authority to set their own speed limits:

Fewer Injuries and Deaths

Speed kills, because drivers cause more crashes at higher speeds, because drivers don't have the time to slow down. The crashes that drivers cause are also more deadly, because of the physics involved. Vehicle on pedestrian crashes that occur at 30 mph are ten times as deadly as crashes which happen at 20 mph. Lowering speeds is especially important in areas that attract pedestrian traffic and where children congregate, given that children lack the ability to accurately perceive vehicle speeds until they begin puberty.

Local Control

Constituents, correctly, hold municipal leaders accountable for their health, safety and welfare in a way that comports with a jurisdictions' distinct characteristics. In order to protect them and help our communities thrive, municipal leaders need the ability to set their localities' own speed limit. To force an inflexible, one-size-fits-all statutory scheme on all municipalities is an untenable state mandate.

¹ A driver who is travelling at 20 mph can come to a complete stop within three car lengths. A driver who is travelling at 30 mph will take six car lengths to stop.

Economic Development

Villages, towns and cities with the power to choose a lower speed limit would have a powerful, low-cost tool to create calmer and safer streets; and calmer streets have been proven to promote retail activity³ and increase residential property values.⁴

Rather than pass a special law for each locality, we ask that you instead support legislation that will give jurisdictions the ability to set their own speed limit at a reasonable level.
